Did You Know...

NAHRO offers a limited number of seminar scholarships expressly for small agencies. Each **John L. Carroll Scholarship** covers the tuition of one national NAHRO seminar registration in 2010. To qualify, your agency must be a current member of National NAHRO and have 250 total units or less of Housing/Section 8 vouchers. The second application period of the John L. Carroll Scholarship will become available in the late spring with a deadline in the beginning of July.

NAHRO currently has an **Auditing Program** which is open to all members of National, Regional and State Professional Development Committees and allows them to audit NAHRO seminars at no cost. In exchange for “at no cost” training, the auditor agrees to attend the entire seminar and to complete and return an Auditor’s Form (which asks pertinent questions about the seminar, faculty, and meeting facility).

The Auditing Program provides the PD staff and PD Quality Assurance Sub-committee with “snapshot views” of seminars (both national and on-site), e-Learnings, and e-Briefings. Additionally, it provides an opportunity for NAHRO’s leadership to have a participatory voice in the quality and relevancy of our seminars.

Please identify yourself as a member of the National, Regional or State PD Committee and the training (seminar title, date, and location) that you would like to audit. Once approved, an Auditor’s form will be forwarded electronically for completion. If Auditors attend the entire seminar

and complete and return the auditor evaluation form within 10 days of the seminar’s conclusion, they will receive a certificate of completion. If they take and pass any accompanying Exam, they will receive a Certificate of Proficiency. For certification exams, the Auditor will be expected to pay for the cost of the exam
